J. Ross Hennon Scholarship Applicant Qualifications (as written in the by-laws)

Section 1 -- The purpose of the Scholarship is to promote higher education among members and their children.

Section 2 -- Scholarship award:

- (A) Scholarship is limited to Lamar University or one of its verified branches.
- (B) One scholarship in the amount of \$250.00 or more if voted upon by the membership will be award in December, either at the District Christmas Party or the District December meeting.
- (C) The Scholarship will be sent to the Lamar University Financial Aid Office, P.O. Box 10042, Beaumont, TX 77710. The Scholarship money shall be sent with the student's name, social security number, and instructions that the money shall be used for spring semester tuition expenses.

Section 3 -- Rules of Selection:

- (A) Highest priority would be given to the children of a District member or an undergraduate member.
- (B) Applicants for the Scholarship must have already completed a semester of study at Lamar University before they can be considered.
- (C) Recipients of the Scholarship must enroll as a full-time student (12 hours or more) at Lamar University.

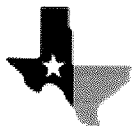
